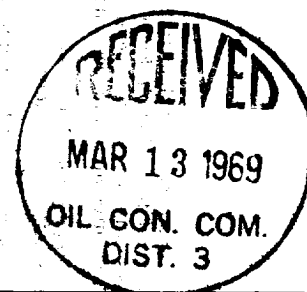

1. 20 Sack cement plug 4640' to 4796' in 4½" OD liner.
2. Shot off 5½" 140 casing @ 3004'
3. Pulled 9 joints casing.
4. 25 Sack cement plug 2930' to 3030' across casing cut @ 3084'
5. Pulled 16 joints casing.
6. 34 Sack cement plug 2135' to 2235'
7. Pulled 70 joints casing. Hole full mud.
8. 18 Sack cement plug in top 30' 8-5/8" 240 surface casing.
9. 4" pipe marker installed.
10. Estimate clean up by May 1, 1968

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. All necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
