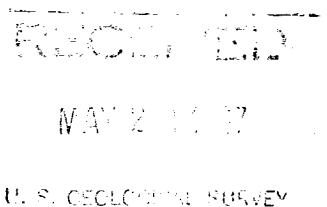
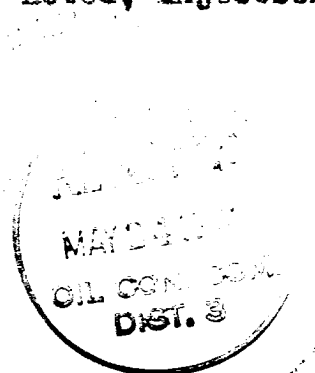

We propose to shut in this Upper Zone injection well as part of a program to determine effectiveness of water injection in the east area of the Horseshoe Gallup Field. We propose to shut in about 22 wells in this area and transfer their injection rates to wells nearer the center of the field. The east area is an area of relatively poor sand development. We expect that this test will last about four months; however, if any adverse effects on oil production are noted, injection will be resumed immediately.
