**Plugging and Abandonment Procedure
Horseshoe Gallup Unit No. 165
Attachment "A"**

WELL DATA:

Location: 1910' FSL, 550' FEL, Section 27, T31N, R16W
San Juan County, New Mexico

TD: 1681'
PBTD: 1635'

Surface Casing: 9-5/8", 36 ppf, J-55 set @ 120'. Cement w/ 125 sks cement.

Production Casing: 5-1/2", 15.5 ppf, J-55, set @ 1679'. Cement with 100 sks cement.

Perforations: 1575' - 1603' w/ 2 JSPF

PROCEDURE:

1. Run in hole with tubing.
2. Mix and pump 21 sacks (24.8 cuft) cement. Spot balanced plug from 1603' - 1425'. Pull up to 1100' and reverse out tubing. WOC for 2 to 3 hours.
3. TIH and tag plug. (Plug must be at least 1475'.) TOH and lay down tubing.
4. Perforate squeeze hole at 170'.
5. Establish circulation down casing, through annulus and out bradenhead.
6. Mix and pump 75 sacks (88.5 cuft) cement down casing, through perforations, into annulus and out through bradenhead. Leave casing and annulus full of cement.
7. Cut off casing and install regulation dry hole marker.
8. Reclaim location as per BLM regulations.
