Plug well as follows:

Spot 500' cement plug from 2840' TD to 2340' (50' above top of Gallup formation).

Spot 100' cement plug from 1415' to 1315' inside 5 1/2" casing across top of Mancos formation at 1365'.

Perforate 5 1/2" casing at 185'. Establish circulation to surface through 5 1/2" by 8 5/8" annulus. Circulate cement to surface.

~~Spot a 50' cement plug from 50' to surface inside 5 1/2" casing.~~

9.5 #/gallon or heavier fresh gel mud between plugs.

Operator will cut off casings below ground level--Weld a 1/4" steel plate across 8 5/8" casing--Erect P&A marker--Clean and restore surface.

Restoration and seeding requirements will be completed when program is recieved from Bureau of Land Management or Ute Mountain Tribal Indian Agency.

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

SPECIFIC INSTRUCTIONS
