7 " at 3908' with 300 sacks regular cement.

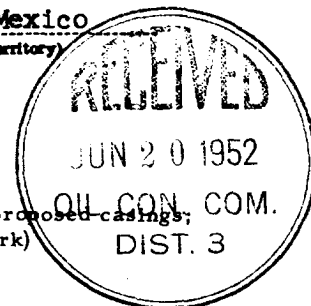

Figure 1. The effect of the concentration of the *Agaricus bisporus* spores on the growth of *Aspergillus fumigatus* on the agar medium. The growth of *A. fumigatus* was measured by the optical density of the culture at 600 nm. The concentration of the *A. bisporus* spores was 10⁴ spores/ml (□), 10⁵ spores/ml (△), 10⁶ spores/ml (◇), 10⁷ spores/ml (○), and 10⁸ spores/ml (●). The growth of *A. fumigatus* was significantly inhibited by the concentration of 10⁸ spores/ml of *A. bisporus* spores. Error bars represent standard deviation.
