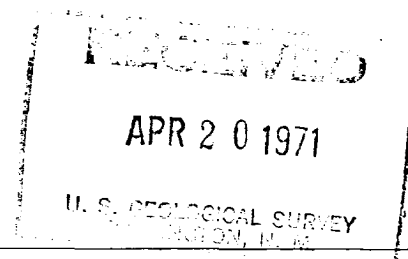

4-1-71 T.D. 2743'. Ran 87 joints 2 7/8", 6.4#, J-55 production casing (2733') set at 2743' w/255 sacks of cement. W.O.C. until completion.

4-7-71 P.B.T.D. 2732'. Perf. 2590-2606', 2616-32', w/2 SPF. Frac w/30,000# 10/20 sand and 29,100 gal. water, dropped 1 set of 32 balls, flushed w/840 gal. water.

Instructions
