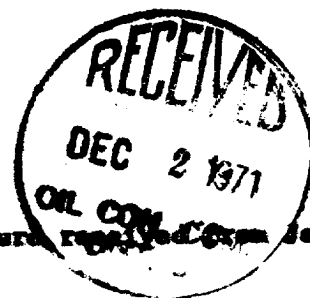

Due to the fact that no commercial hydrocarbons were found in this well, we intend to plug and abandon this well as follows:

1. Spot 100 sacks Type "A" cement 3267-2919'.
2. Spot 50 sacks Type "A" cement 1200-1026'.
3. Spot 30 sacks Type "A" cement 450-350'.
4. Spot 10 sacks Type "A" cement 30' to surface.
5. Cut off wellhead and erect dry hole marker.
6. Clean up location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
