We plan to test six Farmington formation sandstone members in this well. Procedure will be to set temporary bridge plug over Pictured Cliffs pay, perforate Farmington, swab test, stimulate with 5,000 gallons Gas Frac, if necessary. If test is successful, we will request authorization to dually complete the well. If test is not successful, we will squeeze cement the Farmington zones and complete as Pictured Cliffs well.
