



- 1) Notify BLM when plugging is to begin.
- 2) RU cementers and pump trucks.
- 3) Establish injection rate through perfs at 2422-64'.
- 4) Spot a cement plug from PBTD to 1000' (50 sacks cement). Load hole with 6 bbl 9lb mud. (Casing capacity of 2.875". casing is .0058bbl/ft.) WOC for 24hr.
- 5) MIRU slickline.
- 6) RIH with a 2" gauge ring to the top of cement. POOH.
- 7) RU lubricator and TIH with 2" scalloped perforating gun.
- 8) Perforate the interval 830' 32' with 4 JSPF and 90 degree phasing. If 0 degree phasing is the only option, make 2 runs of 2 JSPF.
- 9) Establish circulation through holes at 830-32' between casing and Bradenhead with a dyed water. Circulate until returns are clean and monitor strokes to check volumes.
- 10) Pump 410 sacks of cement down casing, or until clean returns are seen at the surface. Do not displace cement.
- 12) Cut off casing and wellhead. Install PXA marker according to BLM and State requirements.
- 13) Turn well over to John Jenson for reclamation.
- 14) Rehabilitate location according to BLM and State requirements.
