1. Circulated 4½ casing with water from T.D. displacing oil.
2. Spotted 50 sx cement across perfs. Pulled tubing above cement and squeezed 25 sx into perfs @ 700 psi.
3. Free pointed and shot casing off @ 3513'. Pulled & laid down 4½ casing.
4. Ran 4 perforated sub and tubing to 3563'. Spotted 30 sx cement plug 3563'-3463'.
5. Pulled tubing to 1800'. Spotted 30 sx cement plug 1800'-1700'. Pulled tubing to 180' and spotted 30 sx plug 180'-80. Laid down tubing.
6. Set 10 sx surface plug and erected marker.

Instructions
