Drilled 7-7/8" hole to 1290', ran logs. ran 40 jts., 1277.60', 5-1/2" ON 11# K-55 L&C 8ad SH casing set @ 1289'KB, cemented w/150 sx B-J Lite cement w/ 10# gilsonite/sack followed w/ 75 sx Class "B" neat, pumped plug to 1260', plug down 1 p.m. 12/18/75. Good circ., cement to surface, 20 scratchers, 1 centralizers, reciprocated pipe during job. Picked up BOP, set slips, cut off casing. Rig rel 3:45 p.m. 12/18/75.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
