The subject well has been shut in for April 1999 and we would like to extend the SI status to evaluate of the well for uphole recompletion into the Mesaverde interval. This well is in the wildlife restricted area and our rigs are committed for this year, so we will have to plan the workover to begin after the March 31, closure date.

Once the evaluation is complete a NOI will be submitted with details of the recompletion. The casing will be tested before the workover commences and if the casing fails we will remediate with cement before completing the new zone.
