PT - OK. RIH w/RPB & set @ 3870'. Load hole & PT plug to 500 psi-OK. Dumped 100# sand on top. COOH. RU Blue Jet & ran CBL/CCL/GR-Good cement isolation above PC. Perf'd PC @ 1 spf .34" holes @ 3777', 81', 82', 83', 84', 88, 92, 96', 97', 98', 99', 3800'. 01', 02', 03', 04', 05', 06', 13', 14' = total 20 holes. Acidized perfs w/750 gal 15% HCl. RU to frac. Pumped 65 Quality Linear foam w/98.866# 20/40 sand. Flowed back on 1/4" and 1/2" chokes to cleanup. RD flowback equipment. RIH & cleaned fill to RPB @ 3870' and 4020' and removed both. RIH w/2-3/8", 4.7# tubing and cleaned out fill to new PBTD @ 6360'. COOH. RIH w/2-3/8", 4.7# tubing and packer & set EOT @ 6263' w/"F" nipple set @ 6254' and Packer set @ 4005'. RIH w/1-2/2", 2.9" tubing and set EOT @ 3920' w/"F" nipple set @ 3915'. ND BOP, NU WH & PT-OK. Remved BPVs in both strings. Pumped off expendable check. RD & released rig 12/4/01. Turned well over to production to bring both PC & MV back on line. Both BOL on 12/6/01. This well NOT commingled.
