Spudded 12 1/4" hole at 3:00 PM, 6-19-85. Drilled to 268' and ran 6 jts. 9-5/8", 36# casing (250.17' total casing) set at 268' KB and cemented with 150 sx class "B" with 2% CaCl₂ (177 cf). Circulated 7 bbls. cement to surface. Plug down at 4:45 AM, 6-20-85. Waited on cement 11 1/2 hrs. Pressure tested surface casing to 1500 psi for 30 min. Test good.
