12-10-88 TD 2674'. Ran 70 jts. 7", 20.0#, K-55 intermediate casing, 2663' set @ 2674'. Cemented with 380 sks. Class "B" 65/35 with 6% gel, 2% calcium chloride, 1/2 cu.ft. perlite/sx (733 cu.ft.) followed by 100 sx. Class "B" with 2% calcium chloride (118 cu.ft.). WOC 12 hours. Held 1200#/30 min. Circulated to surface.
