1. MIRU PULLING UNIT.
2. BLOW DOWN TBG. KILL WELL W/ WATER ONLY IF NECESSARY.
3. NDWH / NUBOP.
4. PU AT LEAST 1 JT. OF TBG. - TIH TO TAG FOR FILL.
5. TOH STANDING BACK 2-3/8" TBG. (TBG. IS SET @ 2959', THERE ARE 93 JTS. OF 2-3/8" 4.7# J-55 WITH F NIPPLE @ 2926').
6. PU 4-3/4" BIT ON 2-3/8" TBG. AND TIH TO COTB, CIRC. HOLE CLEAN. TOH W/ SAME.

RUN THREE - 1-1/4" SINKER BARS, 116 - 3/4" GRADE D SUCKER RODS (W/ SPRAY METAL COUPLINGS), A SET OF 3/4" PONY RODS (2', 4', 6', 8') TO SPACE OUT, ONE - 1-1/4"x 22 - 3/4" PIN POLISHED ROD AND ONE - 1/1/4"x1-1/2"x10' POLISHED ROD LINER.
