Set 8 5/8" 24# K55 surface casing at 267'. Cemented with 180 sxs class B. Circulated 5 BBLS to the surface.  
Pressure tested casing to 1000 psi. Drilled a 7 7/8" hole to a TD of 3374' on 7-23-90. Set 5 1/2" 17#, 24# K55 LTC production casing at 3364'. Cemented with 145 sxs Pacemaker Lite CIB, tail with 200 sxs Lite CIB.  
2nd stage: 535 sxs Pacemaker Lite, Tail w/60 sxs. Circulated \* BBLS good cement to the surface. CIB Pacemaker B

Rig Released at 7-23-90 hrs. on 10:00.

\* DV Tool set @ 1829 circulated 10 BBLS cement to surface 1st stage  
Circulated 45 BBLS cement on 2nd stage.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
