Set 8 5/8" K55 24# surface casing at 279'. Cemented with 200sx2 Class B w/2% CACL2. Circulated 8 BBLs to the surface. Pressure tested casing to 1000 psi. Drilled a 7 7/8" hole to a TD of 2950' on 9-4-90. Set 5 1/2" 17# K55 production casing at 2940'. Cemented with 1st stage 100sx2 Class G Dowell lite 65/35, 200sx tail loss (2nd stage) 350sx Class G. Circulated 2 BBLs good cement to the surface. 65/35, tail w/ 60sx Class G next.

Rig Released at 9:00 hrs. on 9-4-90.

DV Tool set @ 1475, 1st stage did not circulate cement; water only, 2nd stage circulated 10 BBLs cement

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
