Phillips is requesting permission to run a temporary supply gas line to a point at WFS gas gathering system to the San Juan 32-7 #36A for use during the drilling and completion phases. The line will be laid parallel to the access road, outside of the barrow ditch. The line will not be used for production purposes and will be removed after completion.

Please note the attached maps indicating the point of connect at WFS gathering system to the well location. The temporary surface pipe will be 2-3/8" tubing and will be hydrotested to 1-1/2 times the expected line pressure.
