RIH w/8-3/4" bit and tagged cement @ 335'. Drilled cement from 335' - 380'. Drilled ahead to 3198'. Circulated hole. COOH. RIH w/7" 20# STR&C casing and landed @ 3198'. RU BJ to cement. Pumped 420 sx 65/35 "H" POZ mix, 6% gel, 5#/sx Gilsonite & 1/4#/sx Cello-flake, mixed at 12 ppg. yield 2.1 cf. Preceded by 20 bw and 500 gal mud flush, then pumped tail @ 100 sx C1 "H" w/2% CaCl2, 5#/sx Gilsonite, 1/4#/sx Cello-flake, 0.3% FL-52 mixed at 15.6 ppg and 1.2 cf yield. Bumped plug @ 1230 hrs 8/19/98 with 1500 psi. Circulated 34.6 bbls (194 cf) to surface.

NU WH & NU BOPs. PT BOPs, WH & casing to 200 psi for 3 min and 2000 psi for 30 min. Good test.
