Allocation Formula Method:

3 Hour Flow Test from Mesaverde = 2,721 MCFD & 0 BO

3 Hour Flow Test from Dakota = 630 MCFD & 0 BO

GAS:

$$\frac{(MV) 2,721 \text{ MCFD}}{(MV \& DK) 3,351 \text{ MCFD}} = (MV) \% \text{ Mesaverde 81\%}$$

$$\frac{(DK) 630 \text{ MCFD}}{(MV \& DK) 3,351 \text{ MCFD}} = (DK) \% \text{ Dakota 19\%}$$

OIL:
