GIH w/6-1/4" bit and tagged cement @ 3162'. Drilled out cement. Drilled ahead to 3380' (TD). Reached TD 9/2/98. COOH. RU Haliburton and logged well w/GR/DSN/SDL. Rotated & reciprocated cleaning out to TD.

RIH w/underreamer. Underreamed 6-1/4" to 9-1/2" hole from 3218' to 3380'. COOH. Rotating and reciprocating w/air, foamer and water sweeps to clean up to 3380' for approx. 11 days. GIH with 214' of 5-1/2" 15.5# J-55 casing (liner) and set @ 3331', with top of liner set @ 3117. Top of hanger set @ 3112'. (102' overlap in 7" casing). RIH & perf'd 4 spf, 0.75 " holes, 90 degree phasing as follows:

3268' - 3306' (38' = 152 holes) and 3313' - 3325' (12' = 48 holes) Total of 50' and 200 holes.

RD Blue Jet. RIH w/2-7/8" 6.5# tubing and set @ 3312' with "F" nipple set @ 3280'. ND BOPs. NU WH. Pumped off check. RD & release rig (9/14/98). Turned well over to production department for first delivery.
