MIRU Key Energy #53. Spud 12-1/4" hole @ 1930 hrs 10/27/00. Drilled ahead to 241'. Circ. hole. RIH w/9-5/8", 32.3#, H-40 casing and set @ 236'. RU to cement. Pumped 10 bbls mud clean, 10 bbls water spacer w/dye, and then 105 sx (148 cf - 26.35 bbl slurry) Type 3 cement w/2% CaCl2, 1/4#/sx Cello-flake. Dropped plug & displaced w/16 bbl water. Had 6 bbls circ. to surface. WOC. NU BOP & valves & manifold. PT all to 200 psi - 3 minutes and 1500 # 10 minutes. Good test.

Note: Due to the unavailability of the 9-5/8", 36# J-55 casing, we had to use the 9-5/8", 32.3# H-40 casing.
