Tail - pumped 50 sx (70 cf - 12.46 bbl slurry) Type III w/1/4#/sx Cello-flake, 1% CaCl2. Dropped plug & displaced w/132 bbls H2O. Plug down 2005 hrs 10/8/00 w/1300#. Circulated 8 bbls cement to surface. WOC. ND BOP, set slips and cut off casing. PT - Good test.
