Tail w/90 sx 50/50 Class G poz w/2% gel, 0.35 pps cellophane, 5 pps gilsonite, 0.1% defoamer, 2% calcium chloride (129 cu ft). Circ 60 bbls cmt to surface. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

(10-1-01) Drill to TD @ 5421'. Circ hole clean.

(10-2-01) TOOH. TIH w/127 jts 4-1/2" 10.5# J-55 csg, set @ 5414'.

(10-3-01) Cmdt w/306 sx 50/50 Class G poz w/4.5% gel, 0.25 pps cellophane, 5 pps gilsonite, 0.25% fluid loss, 0.35% dispersant, 0.10% defoamer (438 cu ft). A CBL will be ran at a later date to determine TOC. ND BOP. NU WH. RD. Rig released.
