Dropped wood plug & displaced w/14.8 bbls FW. Plug down 2208 hr 7/20/01. Circ. 8 bbls cement to surface. WOC. NU WH & BOP. PT casing, rams and valves to 200 psi for 3 minutes and 1500 psi for 10 minutes. Good test.
