FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Repair casing hole in 7" by squeezing with 150 sacks. (protect Mesa Verde perfs by dumping sand opposite.)
2. Drill out bridge plug in 4 1/2" Liner at 6019'.
3. Acidize and frac Dakota (Fraced both Dakota and Greenhorn at time of original completion attempt in 1957) after determining need to squeeze Greenhorn perfs by selective evaluation by pump in rates and pressures.
4. Effect routine dual Dakota-Mesa Verde completion.
