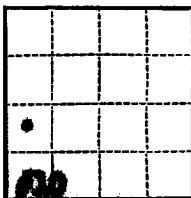

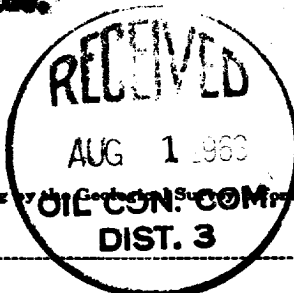
DETAILS OF WORK

It is our intention to drill Well No. 10 to around 1825' to test Gallup formation.

Our casing program is as follows:

- 20' - 7-5/8" ID 17.75 Spiral Weld Casing - to be cemented with 10 sacks regular cement.
- 1825' - 4-1/2" ID 9.55 J-55 Casing - to be cemented with 75 sacks regular cement w/4 gal and 25 gal silicate and 25 sacks regular w/25 calcium chloride.



I understand that this plan of work must receive approval in writing by the District Superintendent before operations may be commenced.
