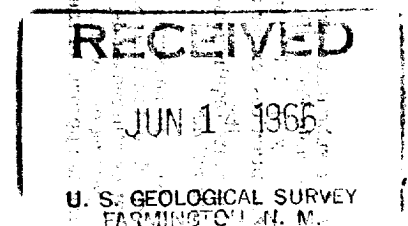
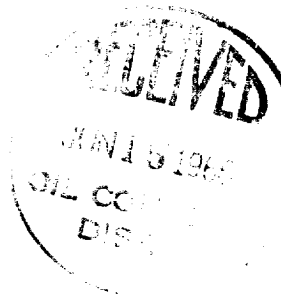

Frac w/26,000# 20/40 sand, 29,970 gallons water w/2 1/2# FR-8/1000 gal. Max. pr. 4000#, BDP 300#, tr. pr. 2000-2500-4000#, I.R. 49 BPM, flushed w/4300 gal. water. ISIP vacuum. Dropped 3 sets of 16 balls each.

Set bridge plug at 5640', tested w/4000#, held O. K. Perf. Cliff House 5045-49, 5058-62 w/4 SPF; 5591-99, 5609-17 w/2 SPF, frac w/37,000# 20/40 sand, 37,080 gallons water w/2 1/2# FR-8/1000 gal. Max. pr. 4000#, BDP none, tr. pr. 2200-2600-4000#. I.R. 41 BPM. Flushed w/3780 gallons water. ISIP vacuum. Dropped 3 sets of 16 balls each.
