Run in hole with bridge plug, set @ 1300'. Place cement on top of bridge plug to cover perforation top to 1100'. Perf 4 1/2" csg @ 83'. Place cement plug inside and outside from 83' to surface. Erect dry hole marker. Rehab surface.
