Propose to spud well with 12 1/4" hole and drill to 200' and set 8 5/8" surface casing. Will cement with 150 sx (yield = 1.18 Ft³, 177 Ft³) of Class "B" and raise cement to surface. Will nipple up 3000 psi BOP assembly and drill 7 7/8" hole to TD of 3150' with fresh water mud system. Will then log well and evaluate for possible commercial production. If successful, will then run 5 1/2" casing to 3150' and cement with 400 sx Pozmix (yield - 1.8 Ft³, 720 Ft³) followed by 250 sx Class "B" cement (yield - 1.18 Ft³, 295 Ft³). Will move off drilling rig and move in completion unit.

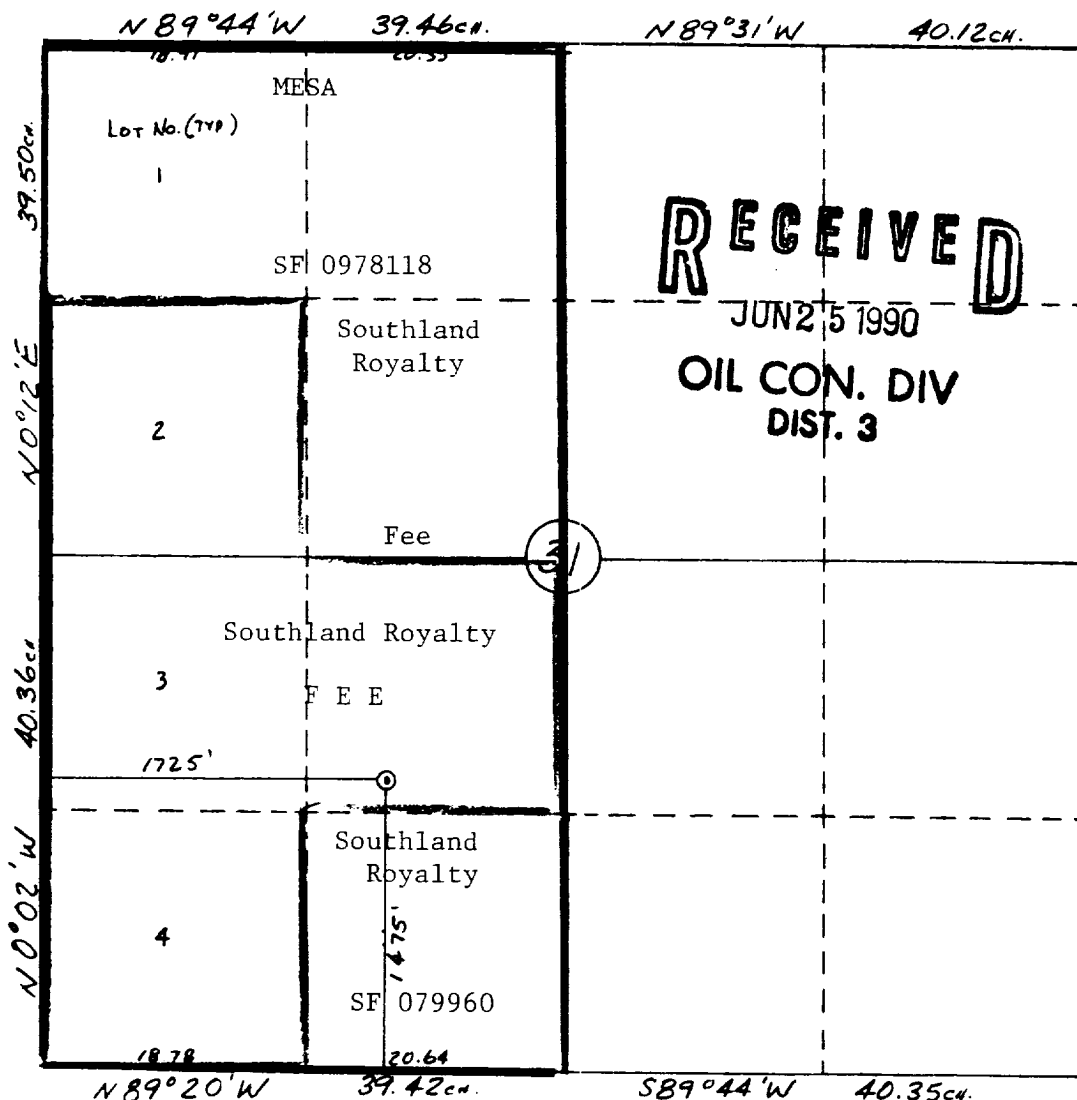
