

We plan to plug and abandon the subject well as follows:

Run in hole with bridge plug, set @ 2950', cap with 50' of cement. Place balance plug from 2100-2000 to cover Morrison + 50% excess.
 Set plug @ Dakota 1825 - 1725' + 50% excess, set plug @ Gallup 1340-1240' + 50% excess. Set plug inside 7" from 100' to surface.
 Erect dry hole marker. Rehab surface.
