 Drill with mud to 4100' and set 7-1/2" casing and cement with 200 sx.  
 Drill with gas through Dakota to approximately 8200'. Hang 4-1/2" liner  
 and cement throughout. Selectively perforate and frac PC and DK effecting  
 an approved type dual completion with packer separation and two tubing  
 strings.

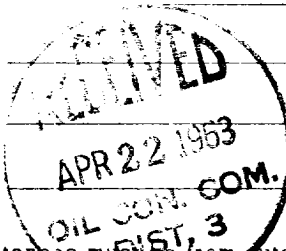

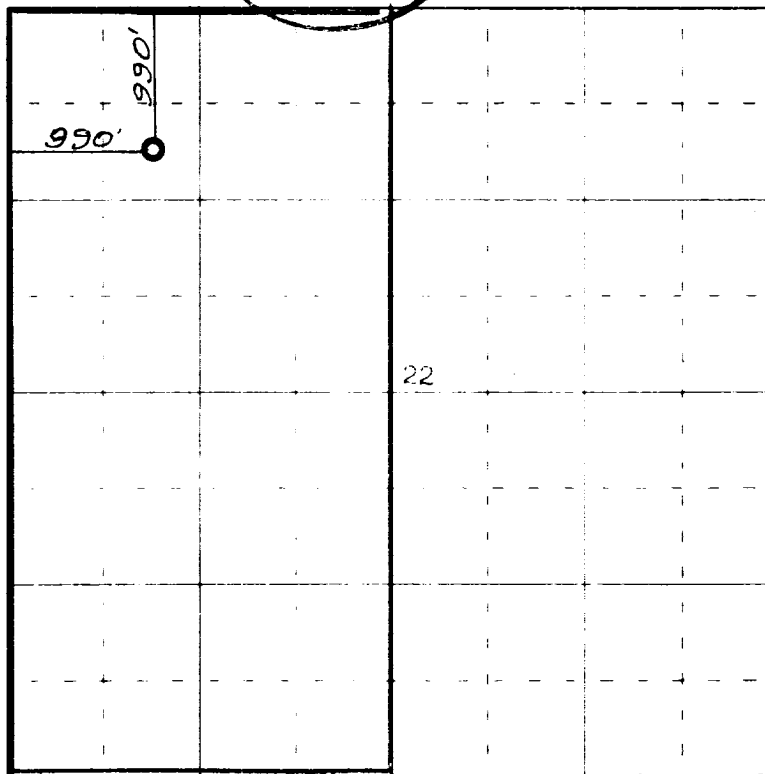
