12-9-81 - Mixed and set plug from 150 to 50. Fluid level fell down hole Mix and pumped 30 sacks class B cement. Cut pipe off 4 ft. below ground level. Mixed and pumped 10 sacks, surface plug. Rigged down and moved off location.
