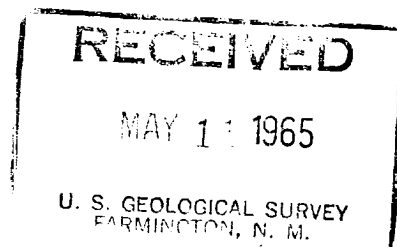
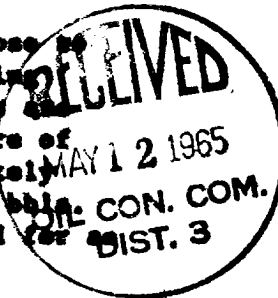

To increase production from the Dakota Formation we propose to perforate and complete the stray sand development overlying the First Dakota Bench. The present perforated intervals are 766'-776' and 890'-893' GLM with a daily production figure of 8.5 BW and 27 BW. Additional perfs will be at approximately 735-738' and 749-753', broken down with approximately 25 bbls water. The well will then be put back on pump and tested for increase in production.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
