DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On January 10, 1951 drilled plug and cleaned hole and started deepening well. Drilled to a total depth of 1809' feet and encountered no production to this depth. On January 15, 1951 plugged back to a depth of 1560 feet and cemented plug and perforated from 1493 to 1502 with 27 holes in the fruitland sand and encountered a good showing of oil. Well now shut in, and preparing for test.
