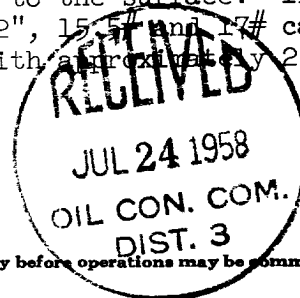

DETAILS OF WORK

The above described well will be drilled to approximately 9600 feet to test the Mississippian formation. Surface pipe will consist of approximately 350 feet, 13 3/8", 48# and cement will be circulated to the surface. If oil or gas in commercial quantities is discovered, 5 1/2", 15# and 4# casing will be set through the pay and it will be cemented with approximately 250 sacks.
