Introduction




Figure 1 - Topographic Map




Figure 2 - Aerial Map

This investigation summary is prepared for EOG Resources, Inc. (EOG) by Larson & Associates, Inc. (LAI) for a produced water release from a poly flow line associated with the Vaca Ridge 30 Fed Com #1 SWD (Site) in Unit G (SW/4, NE/4), Section 31, Township 24 South, Range 34 East, Lea County, New Mexico. The geodetic position is north 32° 10′ 36.45″ and west 103° 30′ 27.31″. The release occurred on August 26, 2015, due to failure of the poly flow line. Approximately 40 barrels (bbl) of produced water was released with about 15 bbl recovered by a vacuum truck. The net loss was approximately 25 bbl. The release occurred over a pipeline right of way with 2 lines buried at about 5 feet below ground surface (bgs). The release covers an area measuring about 25 feet in width by about 350 feet in length. The release crossed the lease road and pooled about 500 feet southeast of the point of origin. The release was reported to the New Mexico Oil Conservation Division (OCD) District 1 on August 27, 2015. OCD issued remediation project (RP) number 1RP-3825. Figure 1 presents a topographic map. Figure 2 presents an aerial map.

Setting

The setting is as follows:

- The surface elevation is about 3,475 feet above mean sea level (MSL);
- The topography is slightly undulating and slopes to the southeast;
- The nearest surface water feature is an intermittent drainage that terminates near the Site;
- The soils are designated as "Simona-Upton association", consisting of calcareous eolian deposits derived from reworking the Blackwater Draw (Pleistocene) and Ogallala (Pliocene) formations, in descending order;
- The soil developed over a petrocalcic (caliche) horizon that occurs between about 4 and 8 feet below ground surface (bgs);
- Groundwater is greater than 200 feet bgs according to records from the New Mexico Office of the State Engineer (OSE);
- No fresh water wells are located within 1-mile of the Site according to OSE records;
- The nearest fresh water well is located about 7.4 miles east of the Site, in Unit C (NE/, NW/4), Section 35, Township 24 south, Range 34 East;

Remediation Action Levels

Remediation action levels (RRAL) were calculated for benzene, BTEX and TPH based on the following criteria established by the OCD (*Guidelines for Remediation of Leaks, Spills and Releases, August 13,* 1993):

Initial Samples and Analysis




Figure 3 - Site Drawing

Initial samples were collected on September 1, 2015. LAI personnel used a direct push rig to collect soil samples at four (4) locations (DP-1 through DP-4) between approximately 4 and 8 feet bgs. Permian Basin Environmental Lab (PBEL) in Midland, Texas, analyzed the upper sample (0 to 1 foot) for total petroleum hydrocarbons (TPH) by SW-846 method 8015 modified. All samples were analyzed for chloride by method 300. Table 1 presents the analytical data summary. Figure 3 presents the sample locations. Attachment A presents the laboratory report.

TPH was below the analytical method reporting limit. Chloride was delineated vertically to 250 milligrams per kilogram (mg/Kg) at locations SP-3, 4 to 6 feet (13.9 mg/Kg) and SP-4, 2 to 4 feet (6.08 mg/Kg). Chloride exceeded 250 mg/Kg in bottom samples from SP-1, 4 to 6 feet (8,080 mg/Kg) and DP-2 (1,680 mg/Kg).

Remediation Plan

- Collect soil samples from 10, 12 and 14 feet bgs at DP-1 and DP-2 and analyze for chloride by method 300;
- Excavate soil to approximately 4 feet bgs from area shown on Figure 3, between DP-1 and DP-2, and install 20 mil thickness poly liner in bottom of excavation;
- Excavate soil to approximately 1 foot bgs in vicinity of DP-4;
- Backfill excavations with clean topsoil and seed;
- Dispose contaminated soil at OCD approved landfill; and
- Prepare final report for submission to OCD.
