Describe Cause of Problem and Remedial Action Taken.* ☐ On Tuesday January 6th, 2015 @ 12:00 Hrs. MST, a flow line leak was found during normal rounds resulting in a release of 0.7 bbls of oil and 10 bbls of produced water with none recovered. Affected area was 50 foot by 46 foot X 5 inch deep on caliche pad and was not contained. The affected area will be remediated according to NMOCD guidelines.

Describe Area Affected and Cleanup Action Taken.* ☐ A total of 2,703 square feet of lease pad was affected. Conoco Phillips (CoP) excavated the leak area 1 foot and exported the soil to a NMOCD approved facility for disposal. On December 2nd, 2015 Basin Environmental personnel were on site to assess the release. Three points within the release area were sampled with depth. All samples were field tested for chlorides and organic vapors, and representative samples were taken to a commercial laboratory for analysis. Point 1 Surface & 1.5' chloride value of 32.0 mg/kg, point 2 surface & 1.5' chloride value of non detect and point 3 surface & 1.5' chloride value of 32.0 mg/kg. The site was backfilled with the clean, imported soil and contoured to the surrounding location.
