A frozen 4" steel line to the heater treater leaked 1 bbl of oil and 59 bbls of produced water onto the ground. A vacuum truck recovered 45 bbls of fluids and the line was repaired/replaced.

Describe Area Affected and Cleanup Action Taken.\*

The affected area is approximately 30' x 30' centrally located around the heater treater on the pad. Remediation will be completed in accordance with a remediation plan approved by NMOCD.
