Please address the following concerns regarding the workplan for 1RP-4550. Please confirm.

- 1. Due to depth to groundwater, vertical delineation is necessary at SP1 and 2. Obtain permissible levels of TPH, BTEX, and chlorides and maintained for 10 ft. bgs.
- 2. According to a Google Earth image, the berm (firewall) appears to have been breached. Establish 1 sample location on the east side of the firewall near the pump and 1 east and 1 west of the tanks for a total of 3 additional sample locations.
- 3. Provide photos of the release and a scaled digital map with the release demarcated.
- 4. Excavate the entire release area to 4 ft. bgs.
