The delineation plan for 1RP-4443 is approved with these conditions. Please confirm.

- 1. Due to the depth to groundwater, vertical delineation at SP1-5 is required until permissible TPH, BTEX, and chloride levels are obtained and maintained for 10 ft. bgs. Use boreholes due to the location of the release with a maximum depth interval of 5 ft..
- 2. Excavate the area around SP1 to 1 ft, SP2-5 to 2 ft. bgs.
- 3. Indicate sampling methodology.
- 4. Provide scaled digital map with extent of release and photos.
