To clarify, using N1 as an example, we are below a chloride concentration of 600 mg/kg at 4' below ground surface (bgs) with a field test value of 510 mg/kg, 6' bgs with a field test value of 380 mg/kg, and 8' bgs with a laboratory result of 223 mg/kg. Therefore, to verify the approximate 10' interval below 600 mg/kg, we will analyze the 12' bgs sample which is the minimum depth of confirmation sample.

Please note and address these concerns regarding the delineation workplan for 1RP-4437.

1. NMOCD's permissible chloride levels for delineation is 600 mg/kg, not 1000 mg/kg and maintained for optimally 10 ft. further in depth with some flexibility due to depth to groundwater at this location. As such, further delineation is required for N1, N2, NW, and Middle with depth intervals < 5 ft. I will accept the following minimum depth of bottom confirmation samples:

N1 at 12 ft. bgs N2 at 20 ft. bgs NW at 18 ft. bgs Middle a at 24 ft. bgs

2. Bottom confirmation samples at minimum 8 ft. bgs. are needed at SE and SW corners.

3. Please provide additional details about the proposed remediation procedure using DeSalt. NMOCD does not approve of using DeSalt to flush chlorides down the soil profile without a plan to collect and/or recycle the resultant effluent. How much fresh water will be used? How will the effluent be collected for disposal or recycled for additional flushings?

Any laboratory analyses need to be accompanied by field chloride tests. Please let me know if clarification is needed or you would like to request a meeting.
