At a minimum, confirmation samples need to be taken at the bottom and sidewalls near SP1-4. Permissible chloride levels are <= 600 mg/kg and 1000 mg/kg for TPH. Method 8015 extended for TPH (GRO, DRO, and MRO) and Method 300 for chlorides are required for closure. Include an appropriately-scaled map in the subsequent report.
