NMOCD approves the proposed additional delineation for 1RP-4724 with these conditions:

- 1. Collect at least one soil sample (0-6" depth) in the oversprayed area. Mark location on a scaled map.
- 2. Extend vertical delineation at SP2 and SP3 to at least 5 ft. bgs in addition to further vertical delineation at AH 1-3. Permissible chloride levels must be obtained and maintained for 5 ft. depth. Confirmatory laboratory samples are required for the first and bottom depths of soil within permissible levels.
- 3. Bottom and sidewall samples of the edges will be required for closure.
