Dear Mr. Foord:

Please address these concerns regarding the delineation workplan for 1RP-3688:

- 1) The initial C141 indicated that the top 12 inches were removed. This information was not provided in the report. Please affirm that contaminated soil was removed to a NMOCD approved facility or appropriate measures were taken. **No excavation activities were performed at the site.**
- 2) Indicate point of release on scaled, digital map. **The point of release from the fiberglass line is unknown.**
- 3) According to current conditions of approval, the maximum interval between soil samples is 5 ft. I have attached this document for your information. **GHD will prepare a detailed workplan for submission to the OCD in strict accordance to the current conditions of approval prior to initiation of additional delineation/assessment activities.**
- 4) Were photos taken at the time of the release and during the delineation work? **Unknown. We will inquire further and keep you updated.**

What is the current status of the proposed additional remediation? **Additional soil delineation activities are planned in the near future (summer 2017) and remediation activities will be conducted following review of the delineation results and workplan approval.**

NB: In the initial C141, the release is in 18S-34E-1 D, while the report indicate N. Please confirm or correct. **The report will be corrected.** Also, I am not sure what you mean by this document uploaded to NMOCD website. To what are you referring?
