NMOCD approves of the proposed delineation plan for 1RP-4855 with these stipulations:

1. Each sample location must have at least two depths (depth obtained and depth maintained at least 2 feet further in depth) with permissible levels of BTEX, TPH extended, and chlorides.
2. Establish at least 3 sample locations (North, South, and West) on the exterior of the bermed area to complete horizontal delineation.
3. Please be advised that complete vertical delineation may exceed 12 ft. in depth.
