NMOCD will consider delineation complete and approve of the proposed remediation plan for 1RP-4868 with these conditions:

- 1. To complete vertical delineation, NMOCD requires at least 2 depths demonstrating permissible levels. For Site 1, laboratory analysis for chlorides at 7 ft. bgs and for Site 3, a sample at 2 ft. bgs.
- 2. On an appropriately scaled map, annotate the dimensions and depths of excavation for each area.
- 3. In a table, provide GPS coordinates and depths of confirmatory sidewall and bottom sample

locations.

4. Photo documentation of delineation and remediation activities.

Please confirm or inform for clarification. The initial C-141 stated that the impacted areas occurred on State surface. Therefore, like approval from NMSLO required. NMSLO may have additional stipulations. Mark Naranjo will be the correspondent in the interim.
