NMOCD approves of the delineation completed for 1RP-4726. For the proposed remediation:

- 1. Confirmation samples are required to complete release characterization. Sample locations must be <= 50 ft. apart.
 - a. For the areas represented by T1, 4, & 7 proposed for surface scraping: confirmation samples at the edges. At least 1 sample each must be at the borders between T6 and T1/T4 and T6 and T7.
 - b. For the areas represented by T2, 5, and 8 proposed for 1 foot excavation:
- Confirmation samples at the edges.
- Confirmation samples at the borders with T3, T6 and T7.
- Bottom samples at 1 ft. bgs must be within permissible levels. If not, proceed to the next foot.
- 2. For the area represented by T6, NMOCD requests that surface removal for elevated chloride levels.
- 3. A scaled map with the confirmation sample locations marked and excavated depths outlined is required.

Please confirm or inform if clarification is required. Like approval from NMSLO is required.
