Please address the following concerns regarding the second delineation report for 1RP-4239.

- 1) Please note that the maximum depth interval between soil samples is 5 ft as per current guidelines. **Noted.**
- 2) As this incident is over 6 years old, what is the status of the well pad? Has removal of any contaminated soil taken place? Are there plans to do so? **Remediation of impacted soil will be conducted following additional site assessment/delineation activities (EM-31 survey, additional soil borings) which are planned to begin summer 2017.**
- 3) What is the anticipated timelines for installation of monitoring wells and soil boring for the additional samples? **Summer of 2017.**
- 4) Please be advised that since this incident occurred on a State lease, Amber Groves (State Land Office) needs to be included in all communications and the SLO may have other conditions. **Noted.**
